## 30 Year Warrantee

This warranty relates to the supply of Harvey Eco Tiles and/or accessories manufactured by Harvey Roofing Products ("HRP"), a Division of MACSTEEL SERVICE CENTRES SA Pty (Ltd). To: -

- 1. Harvey Roofing Products, subject to the terms and conditions set out below, guarantees that the roof tiles and accessories supplied to the owner at the address stated above are fabricated to a functional period of 30 years after installation.
- 2. Harvey Roofing Products also guarantees that the above roof tiles and accessories are manufactured under strict ISO standards and therefore offer a product guarantee of 30 years under normal weather conditions and use.
- 3. Abnormal weather conditions are deemed those conditions, which have caused partial or total destruction of roofs in the same locality i.e. within 10 kilometers of the premises where the partial or total destruction took place.
- 4. The sole liability of Harvey Roofing Products whether in contract or delict for any loss, damage or injury whatsoever or howsoever caused arising directly from any defect, non-compliance of or defective workmanship in the roof tiles and/or accessories supplied shall be subject only to the provision of Clause 2 hereof.
- 5. If, after inspection, Harvey Roofing Products is satisfied as to the validity of the claim made, Harvey Roofing Products shall at its sole option either replace in whole or in parts (as the case may be) or assume the cost of repairing or replacing the roof tiles and/or accessories in situ.
- 6. In the event of a claim arising under this Warranty such claim must be submitted in writing to Harvey Roofing Products within the said warrantee period (as the case may be) and received by Harvey Roofing Products within 30 days of discovery and must have specific reference to this Warranty, owner name, installation address and original invoice to prove date of purchase.
- 7. It is specifically recorded that if Harvey Roofing Products repair or replace any roof tiles and/or accessories in terms of this Warranty they do so on the clear understanding that such repairs and/or replacements shall not be guaranteed for a further period but shall continue to be guaranteed until the original period terminates and on the same terms contained herein.
- 8. This Warranty does not cover nor shall Harvey Roofing Products be responsible for damage of any kind whatsoever or howsoever caused by or due to abnormal weather conditions, lightning,

windstorms, fire, harmful chemicals, fumes or vapors, misuse or abuse, damage or loss whatsoever or howsoever caused by the owner his servants or agents or any other person whatsoever, or by reason of riot, civil commotion or through any other force majeure or viz. major cause whatsoever.

- 9. This warrantee covers the functionality and structural integrity of the tile and any discoloration due to natural weathering is excluded.
- 10. This Warranty only applies to product liability and Harvey Roofing Products shall not be responsible in anyway whatsoever for the actions of installers / incorrect installation and the owner herby indemnifies and holds harmless Harvey Roofing Products against all and any such actions.
- 11. Effect shall be given to this Warranty subject to the foregoing terms and conditions only if this Warranty has been unaltered, completed and signed by the owner, the supplier or installer (as the case may be) and returned to Harvey Roofing Products by the supplier, installer or the owner.
- 12. Where the repairs or replacements are effected by Harvey Roofing Products or by another party under Harvey Roofing Products instruction, the owner undertakes that Harvey Roofing Products decision as to whether the repairs or replacements have been satisfactorily performed shall be final and binding on the owner.
- 13. All other warranties, descriptions, representations and conditions as to fitness or suitability for any purpose whatsoever, tolerance to any conditions, merchantability or otherwise (whether of a like nature or not) and whether express or implied by law, trade, custom or otherwise are expressly excluded from this Warranty.
- 14. Notwithstanding anything else contained herein Harvey Roofing Products shall not be liable for any consequential, indirect or special damage or loss of any kind whatsoever or howsoever caused nor shall Harvey Roofing Products be liable for any damage or loss caused to the owner, the owner's servants, agents or any other person whatsoever. The owner indemnifies and holds harmless Harvey Roofing Products against any claim by the owner's servants, agents or any other person whatsoever (whether similar to the foregoing or not) in respect of any loss, damage or injury arising from any defect non-compliance of the roof tiles and/or accessories supplied or arising out of any breach by Harvey Roofing Products of the terms of this Warranty, or in delict, negligence or out of any other cause whatsoever.
- 15. This Warranty is subject to installation in accordance to Harvey Roofing Products installation manual and installation recommendations.
- 16.
